- The food shall be ready to serve 15 minutes prior the scheduled dining time. No delay will be entertained under any circumstances. However, request for delay may be considered under unavoidable circumstances with prior information or approval from the competent authority of RCTRC, Kalyani.
 - The head count of trainees availing dining facility shall be provided by RCTRC representative on daily basis.
 - Items shall be prepared *LIVE*: The caterer shall have to make necessary arrangements required for preparing food items through a “LIVE COUNTER” facility. The caterer shall have to bear the responsibility for arranging utensils required for cooking and serving.
